CORRIGENDUM / PRE-BID CLARIFICATIONS

Subject- Tender for “Providing Mess & Catering Services at IIM Sambalpur”

With reference to the pre-bid queries/observations received from the prospective bidders in connection with the above-mentioned Tender, the Institute has examined the same and hereby issues the following clarifications/modifications to the relevant provisions of the Tender Document.

The clarifications/modifications specified below shall be read in conjunction with the respective provisions of the Tender Document and shall form an integral part thereof. Bidders are advised to take due note of these clarifications/modifications while preparing and submitting their bids.

1	7 (n)	Rebate may be allowed to students if they do not use mess facility minimum for 03 days at a stretch. In such cases, the concerned student must inform the mess manager/supervisor on email at least three day in advance.	With reference to Tender Clause No. 7(n) and Clause No. 10(c), it is hereby clarified that the minimum period for availing rebate on account of non-utilization of the mess facility shall be 03 (three) consecutive days .
2	10 (c)	While calculating the Monthly Mess Bill amount, in respect of student diners who stay away for more than two days on official assignment of the Institute or under medical grounds norms decided by the institute administration/mess committee will be followed.	Accordingly, the provisions of both the above-mentioned clauses shall be read and interpreted as 03 consecutive days for the purpose of calculation of rebate

3	10 (a)	The payment will be made within fifteen days from the date of receipt of the monthly mess bill	With reference to Clause No. 10(a) and Clause No. 10(b) of the Tender Document, it is hereby clarified that the payment processing period by IIM Sambalpur shall be 15 to 30 days from the date of receipt of the complete monthly mess bill/invoice subject to verification and processing as per the applicable procedures of the Institute.
4	10 (b)	Payment processing period from IIM Sambalpur side will be Up-to 45 days after receipt of invoice complete in all respect from the vendor with no subsequent written objection from IIM Sambalpur	
5	Annexure-14 Point No. 4	The quoted rates shall remain firm and fixed throughout the contract period , and no escalation shall be permitted.	It is hereby clarified that the quoted rates shall remain firm and fixed throughout the initial contract period of 02 (two) years and no escalation shall be permitted during the said period.
6	7.1.1. (d)	Payment shall be made based on the actual number of meals served, in accordance with the terms and conditions of the Contract.	Clause No. 7.1.1(d) shall stand deleted and shall not be considered for the purpose of the Tender.

Note- All other terms, conditions, eligibility requirements, technical specifications, and provisions of the Tender Document shall remain unchanged.
